

Fred and Virginia Olivieri are being honored by Dean and Grace Olivieri, Christine Olivieri Hackett, and the Olivieri Family. **Fred and Virginia Olivieri** founded the Fred Olivieri Construction Company in December of 1959 in the basement of their home. What started as a home building business, quickly turned into commercial contracting when the company landed its first commercial job, an addition to a church in McDonaldsville, Ohio.

"Philanthropy has always been important to our parents," say their children, Chris and Dean. "They say 'modeling is the best way to teach children.' Mom and Dad showed us by doing. It was simply instilled in us to give back from a young age." They have been life-long members of St. Michael's Catholic Church which has nurtured the enduring faith that has guided them throughout their lives.

Their desire to put their faith into action has led them to be very generous to causes they love in their community, including Walsh University, Aultman Hospital, Mercy Medical Center, and The American Heart Association. They have been Alexis de Tocqueville Society members for nearly 25 years, and have passed that spirit of giving and making a difference in their community on to their family and entire company.



Dick and Lynn Kempthorn are being honored by their sons, Eric and Jim Kempthorn, their daughter, Dana Parker, and the Kempthorn Motors Employees. **Richard and Marilynn Kempthorn** were lifelong residents of Canton Ohio, settling on a farm in Jackson Township after their marriage in 1956. In 1964, Dick bought his father's Dodge-Chrysler auto dealership and went on to develop one of the largest auto malls in northeast Ohio comprising of 10 auto franchises at one location. Until his passing in February 2019, he reported to work at 1449 Cleveland Ave nearly every day.

Lynn was always at Dick's side with support, and was the backbone of the family, keeping the "trains running on time." Having had three children within 4½ years, the hectic schedules of school athletics and a farm full of animals was not a job for the faint of heart. Eric recalls, "Dad never walked in the door from a day of work without finding his beloved 'Lynn' and planting a kiss on her." As the kids recalled, "She was his world during those crazy busy years, and he showed us by example how great marriages work."

Dick and Lynn taught the family that "to whom much is given, much is expected" and they didn't just say it but lived it. They gave generously to hundreds of causes but near and dear to their hearts were the United Way of Greater Stark County, YMCA, and their beloved church family, Bethel Temple Assembly of God. Revered by his employees as a leader, coach and counselor, he lived by the bible verse, "Do unto others as you would have done unto you." The legacy that Dick and Lynn left their family and company is one of setting goals, persevering, and caring for family and their community.

Recognizing the incredible need in our community due to the economic impact of the virus, United Way set up the COVID-19 Impact Fund, a dedicated resource for working families affected by job loss or reduced work hours caused by this unprecedented public health emergency.

The fund provides financial assistance to help meet families' basic needs during this time of crisis. With the community's help, we have assisted more than 230 families including 325+ children.

The demand continues as our community struggles to recover and rebuild from the pandemic.

Once again, we have been truly inspired to see the outpouring of support from our neighborhoods. As our community has pressed pause, many have had to find new ways to keep going and you have stood side by side with your neighbors and helped at a time when, for many, help seemed far away.

In addition to the work we are doing in response to the pandemic, we are very excited to partner with the Dismantling Racism Coalition of Stark County and create transformational change! August 10 was the day we, as a community, began to change the narrative! The Unity Challenge to Dismantle Racism had over 2,000 participants in a challenge that helped them explore their unconscious attitudes about race, power, privilege, and leadership. Including us, almost 40 workplaces and organizations have endorsed the challenge!

Benevolence and commitment are what make Greater Stark County a better place to live and work.

You have made a difference and strenghtened our community's life.

732 volunteers, 42 service projects, 40 nonprofit or school locations and 39 workplaces participating in 12 cities = the largest Day of Caring ever on May 17.



Handmade Cards 691 cards were crafted with personal notes for agencies to distribute at holidays, birthdays and to lift the spirits of their clients.



Stone Soup

This past year, 2,800 meals were created by more than 350 community members through workplaces or individuals. Meals were distributed to area shelters, housing and community centers.



Purse Kits

320 purse kits were assembled by more than 100 volunteers at the Massillon Purse Project. The kits were filled with donated personal care items and distributed to local women.



Literacy Kits 79 volunteers created 250 fun, engaging literacy kits for children to take with them over winter break.



Read Across America 32 volunteers promoted early literacy and Kindergarten readiness with three events over two days. They encouraged a love of reading with storytimes and family activities.
